8. Presentation of Credentials Committee Report - Credentials Committee Chair, Allen Hahn DTM

Credentials Committee Chair reported that each club in good standing is eligible for two votes, one for the President and one for the Vice President Education.

There are 83 clubs in District 17 with 64 clubs in good standing.

To achieve a quorum, one-third of the Presidents and Vice Presidents of eligible clubs must be represented. The total number of Presidents and Vice Presidents Education is 128, requiring 43 to achieve a quorum.

There are 39 Presidents and Vice Presidents Education in attendance today. As such we have not achieved a quorum.

There are also 16 District Executive Committee members represented. District Executive Committee members do not count towards achieving a quorum.

The total votes available are 55.

In today's meeting, a simple majority is 29 votes; and a 2/3 majority is 37 votes.

District Director, Tim Blackburn DTM announced that the Credentials Committee report is accepted and thanked the Committee for their work.
