1. Call to Order

11. District Budget Review & Approval

District Director, Tom Bielski, submitted the Proposed Budget as distributed via email for Review and Approval. (See Tabled Report)

He was pleased to inform the Committee that we had passed with flying colours.

14. District Success Plan Review & Approval

District Director, Tom Bielski, presented the District Success Plan for year 2025-2026. (See Tabled Report) He stated that this year would still be a strenuous year with much work to do to continue the success of last year, but he had faith in this team of District Officers. He stressed the integral part each of us play in making this year even more successful as we had outlined in this report. He also identified that this Plan is a live document and that the Trio would revisit it often throughout the year to confirm we are meeting the plan and to update if required.

Program Quality Director, Maree Pickens spoke to the Training, Distinguished Clubs and Eligibility sections of this plan. She stressed that well trained club and district officers was the most important factor to our district's success. She is happy with our results so far, but we do have a way to go to complete the high standard the Trio have set. She is endeavouring to bring high quality leaders and speakers to our district often throughout the year, not only in person but virtually as well.

Club Growth Director, Desmond Miranda, spoke to the club growth and membership sections of the plan. He emphasised the importance Division and

Area Directors play in building our district. If leads come your way, please act on them immediately or hand them to him for follow up. He asked all members of this committee to be on the look out for leads at all times. The other integral element of this plan is to maintain the clubs we already have and to build them. Area Directors play a big part in facilitating this aspect. The Trio is relying on Area Directors to being diligent in understanding the nature of each club and to step in or ask for help from the Trio, should any club begin to struggle membership wise.

15. Presentation of Reports

a. District Director Report

District Director, Tom Bielski, thanked the members of this committee for their acceptance of roles and their dedication to our district. He wants to build on the success of last year and make our district even stronger and larger. He declared that the first two months of this Toastmasters year had been hectic with Club Officer Training before the year even started, District Leader Training in Philadelphia and the International Convention then returning to Perth for this meeting. He particularly asked all members of this committee to immediately advise him if they are struggling with their role or need help. Please do not carry on if you are feeling overwhelmed. He is confident we can finish the year as Smedley Distinguished status, so long as each member completes their own tasks to the best of their ability. (See Tabled Report)

b. Program Quality Director Report

Program Quality Director, Maree Pickens, congratulated all members of this committee for their work so far in this Toastmasters year and stressed the importance of completing one goal at a time. The first goal is to ensure all clubs submit their Club Success Plan to Toastmasters International in order to be eligible for any level of distinguished status in the Distinguished Club Program. At the moment we have 36 clubs have submitted their plan to Toastmasters International and 7 others have submitted to District 17. She will ensure these 7 are submitted in time. We have 15 clubs still to submit their plan. She asked Area Directors to reach out to clubs to support them if required. She has a video showing how to fill this plan in on the D17 website. She would like all plans submitted by September 25 to allow some breathing time before we move on to our next goal.

Regarding training, she is delighted with the numbers so far, but is certain that we can make this even better. At the moment, 57 of our 58 clubs have achieved the minimum of 4 Club Officers trained. She is hoping for 100% here as well as in District Officer Training. There are a couple of Area Directors still requiring additional training and she is working with the Division Directors to achieve this. (See Tabled Report)

c. Club Growth Director Report

Club Growth Director, Desmond Miranda, stated that his main focus this year is to have all our existing clubs remain strong, or even build stronger and to build new clubs. He is following up on at least 4 leads at the moment, and these all look highly likely to be successful in chartering. He is on the lookout for members willing to be Club Sponsors, Mentors and Coaches as always. He asked all members of this committee to please be aware of any members who may be interested in one of these roles and alert him to this fact so he can work with these members. (See Tabled Report)

d. District Public Relations Manager Report

Public Relations Manager, Angela Booker, stated she is excited about her role and the way the year has begun with the highly successful Gala Awards Night. She was particularly thrilled with the number of attendees and the fun that was had on the night. She welcomed all the members of her team and thanked them for their commitment to the success of the PR unit this year.

Her next objective is Voices of Experience. The first portion of this initiative is complete, and members will begin to see the outcome of this shortly. Coinciding with this initiative is the nomination of some members of our district in the Senior of the Year Awards. She hoped they would be recognised for their wonderful work as volunteers in Toastmasters WA. The next fun night is the Trivia Night which will be held in November and details will be distributed soon for this event.

She encouraged Area Directors and Division Directors to encourage members who have any skills relevant to this team to reach out and to become a part of the PR team. (See Tabled Report)

f. Area N22 Director Report

Area N22 Director, Jo Parker, stated she feels most clubs in her Area Are doing well. She has done an informal visit to each club, and she has begun her formal visits. Banksia Speakers has only 10 members, but they are trialling a new time for their meetings in September, and she is looking forward to seeing how this works for them. g. Area N23 Director Report

h. Area N24 Director Report

She only has to visit Easy Speak Ellenbrook, but she knows the Club and the Officers quite well, so this will be a comfortable visit. She has held an Area Council Meeting which was successful. i. Area S31 Director Report

Area S31 Director, Somesh Ganesh, expressed his joy that on visiting 4 of the 5 Clubs in his Area, they were all excited for the year ahead. He has not visited CGH which is a corporate club which meets at 12 noon. This may be a problem and he has asked if Robyn Richards would be able to attend in his absence. He is awaiting a reply.
