Protocol 8.4

District Fiscal Management

Electronic Payments, Cash Advances, and Debit Cards

Cash advances for budgeted district expenses (limit \$100) may be extended so that members need not spend personal funds on behalf of the district.

District 17 Procedures Financial Management

Paragraph 2

"District officers may be reimbursed by District for pre-approved expenditure for the achievement of the District's goals, and in accordance with Toastmasters International Policies and Protocols, subject to the District Budget. Policy on reimbursements for each year will be decided by the District Management Committee when determining the District Budget, subject to endorsement by the November District Council Meeting."
