He introduced all those on the official table; Ross Wilkinson DTM, Lieutenant Governor of Education and Training; Pascale Amberville-Colby DTM, Lieutenant Governor of Marketing; Robyn Richards DTM, Public Relations Officer; Tim Blackburn, District Treasurer; Sandra Morton, District Secretary.

District Governor, Mark Richards reported the meeting had a quorum with the attendance of 14 of the 22 officers.

8. Report of Audit Committee

Tim Blackburn gave an overview of the audit process.

Tim reported that the auditors found everything to be correct as per Toastmaster International rules and regulations. The report has been submitted to Toastmasters International.

A copy of the audit report is attached.

9. Treasurer's Report

Tim briefed the meeting on the current balances in District accounts

- Available funds of \$46,000.
- \$35,000 for convention. This figure includes fund raising and sponsorship monies.
- \$20,000 Convention ticket sales. Tim said he believed there were 80 registrations for convention. However he has not checked with Debbie Hewitt as to how many registrations have not been paid for. Currently we require seven more bookings to break even. However we are 26 short of the 125 members we anticipated.
- Tim stated he could not comment on how much income we will receive from the latest round of renewals as TMI has not yet updated the reserve account.

Motion: "that the Treasurer's report be accepted".

Robyn Richards asked the meeting if they understood what the reserve account was and then gave a brief overview.

Liz Fisher enquired as to how much the District gets from membership renewals. Mark Richards stated we get \$6.00USD per member.

Peter Jordan asked if it was put into a separate bank account.

Greg Madden asked how much profit is budgeted for from Convention. Tim said if we are expecting around \$7,000 profit but could be higher with fund raising.

Allan Burt suggested if Area Governors did not use the \$100 they were allocated, the monies could go to Convention.

10. Alignment Committee report

LGM Pascale Amberville-Colby presented the Alignment Committee report.

PAC gave the report highlighting certain points. Fix up morning star to Guildford stars.

PAC said he had suggestions on the realignment and how some areas could have 6 clubs.

Motion: "that the Alignment Committee report be accepted". Moved: PAC, Seconded VP. Carried

Liz Fisher asked about the rational of putting Noranda in area N22 and Highgate in N23 as she thought it should be around the other way. Pascale answered he would put it to the committee for consideration.

Leonor Ragan said that as Area C4 had lost A-Team shouldn't GunsNRoses Gourmet be put into C4 instead of C2. Pascale and Mark Richards both said that it was better to keep five clubs in an Area instead of having six, which is what would happen if GunsNRoses were put into C4.

Vicky Post enquired to why we did not create a new Area. Mark Richards replied that this would be difficult as it is hard enough to find good leaders to fill the roles of 13 Area Governors.

Mark Richards said that there was merit in moving TEEM to an Area in Southern Division, but as TEEM looks to be folding it will be a burden to any Area it is assigned too.

Mark Richards explained how the rules changes next year would change how an Area became Distinguished.

Mark Richards said he had been contacted by Ian Pickens who suggested swapping Ellenbrook to Area N23 and Highgate to Area N24

Pascale concluded by thanking everyone who has provided feedback on the realignment proposal.

Scope of Audit 1.1 The Audit Committee, comprising of Terrence Cheong (chairman), Elizabeth Dai and Raj Thethy, audited the accounts for District 17 for the first six months of the financial year 1 July 2011 – 31 December 2011 in accordance with guidelines issued by TMI Finance. 2. Findings

- 2.1 The Audit Committee believes that the accounts accurately reflect the financial transactions on and the status of the District 17 accounts for the period 1 July 2011 – 31 December 2011 and has found the accounts and supporting documentation to be in order.



District Governor Report - April 2012 Overall performance

As a District we are performing very well indeed. We are one of only four Districts in the world to achieve 4 of the 5 goals set by TMI. We just have to meet the membership payments target of 2327.



Membership Dues

Membership renewals are not as bad as they seem but they still need to be looked at and followed up by Area Governors. All clubs except Roetoric (which is in club rescue mode) have now paid their minimum amount of renewals. We have paid 1978 payments towards our goal of 2327, which is 85%. This will change significantly when the new figures for April are released tomorrow as many clubs paid their renewals late. I will be sending out a list to all Area Governors of all members who have not renewed so they can follow up with each club.

Area Visits

Area Governors visits need to be completed by the end of April and you have till the end of May to lodge them. Well done to Areas C1, N23, S31, S33, S34 & S35 for completing their visit reports. Of concern are these Areas with no reports lodged C2, C3, & C4. N22 & S32 have lodged just 1 visit. N21 & N24 need 1 more visit lodged for completion.

District Website

The District website is now looking fantastic with the addition of the calendar and the electronic version of our District newsletter, Black Swan. If you have any ideas for improvement or new resources to add to the site, please contact myself or Webmaster, David Nicholas.

District 17 Convention

Everything seems to running smoothly as we approach our District convention. There have been 90 registrations lodged with the raffle of a free registration at Division finals being very successful. I think we will meet our target of 150 registrations, please keep promoting the Convention at every chance you get.

Education Awards

We have met all educational goals but I must encourage those clubs who have not yet lodged a CC or AC for the year to do so. Only 5 Areas have met their CC goal, 10 Areas have met their AC goal with C2, C3 & C4 having only 1 AC lodged between them.

Distinguished Areas

Congratulations to Areas C1, N23 S31, S32 & S35 for reaching Distinguished status. I will be sending out a list of Area to-dos to all Area Governors soon so you will know where to concentrate your efforts in the next few months we have left.

New Clubs

Well done to new clubs Applecross (which have attained 10 goals in their first year) and CPA. Healthy Toastmasters is about to charter in the next few weeks and we have 2 other clubs that we hope to charter before the end of this year being BPW Toastmasters and Gourmet Guns n Roses.

Summary

With a concerted effort in the next 2 months we will definitely reach Distinguished District status in our first year. Renewals are a priority for follow up and please concentrate on the KPIs in your Area & Division.

Well done to all Area & Division Governors for running some fantastic contests and I think the standard of our speakers is very high indeed.

Our Speechcraft program is the best in the country with all courses filling within a few months of advertising. Well done to Maree Pickens for her professional approach to this program and all the Co-ordinators that have run them.

The projects I have undertaken in 2012 include the Club Website Audit, The Positive Promotion Premiership, the Club and Area Newsletter Contests and the organisation of the Change Over Dinner and Awards Night. The Club Website Audit and the Positive Promotion Premiership have both proved highly successful and I feel confident that the Change Over Dinner and Awards Night will be also.

Club Website Audit

To fulfil my duties as District PRO, I am required to conduct an audit of all club websites to ensure they are current and easily accessed both from the TMI website and the District 17 website. I conducted this during January 2012, looking for use of the new branding as well as current details regarding meeting times, venue etc. I found many clubs had already embraced the new branding and Freetoasthost 2 websites. My findings regarding individual club websites were sent to Area and Division Governors. I feel sure they forwarded the information onto their respective clubs for action or congratulations.

Generally, I believe we need to "personalise" our websites with photos of current members and events while still keeping the new branding and layout which Toastmasters International are wanting.

Positive Promotion Premiership

At this stage I have had 23 clubs claim points in the PPP and the Premiership Table has these clubs are at the top of all other clubs. The vying for top position is hotly contended by 2 clubs at present and I am expecting more claims from both clubs before the end of this month. The last two weeks I have received many claims and the top four positions have changed several times. This makes it exciting to watch and be a part of.

I am particularly excited to see many clubs actively seeking articles in local newspapers and 3 clubs have had a spot on radio. The other astounding aspect of this contest is the ingenuity and "thinking outside the box" of VPPRs as they find new ways to promote their club. The creative minds of Toastmasters in WA is to be commended.

I believe there are still clubs out there which are unaware of the contest so I invite Division and Area Governors to promote and explain the contest to clubs when they visit. At every event I attend, I ask if any clubs have NOT had a visitor this year and never has a hand gone up. If this is the case, every club should have claimed points and be registered on the PPP Table. My goal is to have at least 30 clubs claiming points by the end of this Toastmasters year, so if your club has not yet done this, I want to hear from you!! You can find all the details on the District 17 website in "Help for VPPRs". There's no reason why more clubs can't be contending for the prize of *The Successful Club Series* of manuals plus a gold premiership cup to display at your meetings.

Next year I will be encouraging the incoming District Public Relations Officer to work with me in fine tuning a wonderful contest which gives clubs a blueprint for achieving "Distinguished" status in the DCP. I believe, as the contest becomes better known and understood, it will become a hotly contended prize in District 17.

Change Over Dinner and Awards Night

This event will take place on Friday July 6th, 2012 and is the time to celebrate the year of hard work and welcome in the new District Officers. It is a major event on the District 17 calendar and always a triumphant night.

I have booked Tompkins on Swan for this event. Catering choices at this venue are delicious and the price will remain the same as last year. The venue is superb with stunning views of the Swan River and the city. We will need to advise final numbers closer to the event so please be diligent in promoting this event to the clubs in your Area or Division. There will be no late bookings accepted. The flyer is on the District Website with all details and payment methods.

I once again invite Division Governors to recover all perpetual trophies for this night, as much alteration needs to be done prior to this event. Please also begin thinking about your awardees as I will require the details by mid June.

Club and Area Newsletter Contests

Earlier this year I announced the Club and Area Newsletter Contests in *Black Swan*. I invite all clubs and Area Governors to send 1 electronic copy of a newsletter to me for this contest.

So far I have received 1 Area Newsletter and 5 Club Newsletters. I encourage you to promote this to Clubs over the next few weeks and Area Governors to join the contest. You have much to promote to the members of your Area. What are you waiting for? I know this has been a popular contest in the past and I trust this year will be no exception.

District Newsletter – Black Swan

It took several months for our new district newsletter to establish but with the hard work of our webmaster, David Nicholas, and our editor, Gerry Prewett, it is finally beginning to come of age. I know it will keep improving and I believe the name is so significant with Western Australia that we should all be very proud to promote this important part of public relations to every club and every potential member in Western Australia.

Encouragement to all clubs and members to submit articles is essential for the ongoing success. Black Swan belongs to us all – be a part of it!

Conclusion

The Club Website Audit highlighted many excellent websites as well as the ones needing action and all concerned were advised of the findings.

Please encourage your clubs to submit entries into the Club Newsletter Contest and have a go at producing your own Area Newsletter to submit.

I am looking forward to presenting the gold cup and the set of manuals to the Positive Promotion Premiership winning club at our inaugural Convention in May. They will have worked very hard to achieve this prize.

Our Change Over Dinner and Awards night is set to be the most exciting ever in a brand new venue where we can all celebrate together our first year as District 17.

I encourage all members in WA to become a part of the wider Toastmasters community by engaging in the fabrication of our District Website and Newsletter.
